## Pickle Ball and Floor Hockey Popularity Growing at Lakeview

Parks and Recreation staff has successfully administered some new drop-in programming for Pickle Ball and Floor Hockey on the Olson Arena at Lakeview with grant money from the Michigan Health Endowment Fund. Interest was sparked in Pickle Ball from a clinic that was held back in July where nearly 40 people attended. Since this clinic, there has been a steady group of players coming in. Some of the players have noted that the weather is so nice outside and that they are trying to enjoy it while it lasts, but it is still great to have a place to come to when it's raining or really windy. There has also been some more interest expressed in alternative times in addition to the current drop-in sessions for Pickle Ball. Staff has evaluated alternative times, and has come to the conclusion that Monday and Thursday evenings could be supported since Lakeview Arena is occupied on these evenings by Dead River Derby practices on the Russell Arena (From Aug. 24 to Sept. 10), drop-in Pickle Ball sessions will be available Monday and Thursday evenings from 6-9 p.m.

Floor Hockey has been gaining a following as well with many of the local youth hockey players coming to Lakeview in the afternoons. Players now have the opportunity to develop skills and get some exercise now that this program has come to Lakeview. This is also a great opportunity for those individuals who want to play hockey, but may not be able to ice skate.

Summer. A great time in the U.P. for all of us including those of us on staff here at the City, except for one thing. It's budget time for us. By that, I mean we are putting together our budget for the following fiscal year which begins on Oct. 1 each year. I would imagine that budget time for anyone who works with a budget is stressful, but for us it's more so because we work with public dollars in what we feel is the best in public interest.

It's not always an easy task given that the funds are limited and just about everyone has a preference where they should be spent. Rest assured, our CFO, Gary Simpson, takes his task very seriously and expends a lot of energy making sure that the rest of us do as well. Sometimes we even feel sorry for him. Gary tells us what we have to spend and all department heads spend a good part of the summer making each of our departments work with what we have. And, believe it or not, by law we have to balance our budget. In other words, we are not allowed to spend more than we have. Seems like a novel idea these days, but in practice it actually works.

Budgets have been somewhat more stressful the last few years because of something called a Tax Tribunal. The recent rage all over the State of Michigan seems to be challenging property tax assessments promulgated by recent box store actions often referred to as "Dark Store" assessments. Marquette City is not currently dealing with the "Dark Store" issue, but is facing several Tax Tribunal cases that can be just as devastating to a municipal budget. We have always dealt with challenges to property tax assessments, but they are usually resolved at the local level through the Board of Review which is held twice per year in our Commission Chambers.

Lately, however, some larger City taxpayers have opted to skip the Board of Review and go directly to the Tax Tribunal which can often take years to resolve. Tax payers involved with the Tax Tribunal still have to pay the currently assessed tax, but if the Tax Tribunal resolves in a lesser amount we have to give the money back. But what do we do in the meantime? We act like we never had the money to begin with. Which can be difficult for us but smart to do. So, as the public, you can rest assured that we have a City Manager, Chief Financial Officer and City staff that plans accordingly to offer the best possible services while not putting us all in financial straits. You should be thankful; I know I am.

The meetings are intended to provide informal opportunities to discuss issues within the community, and to give citizens a chance for direct dialogue with City staff about interests and concerns.

## November General Election

The City Clerk's Office is preparing for this year's General Election, which will take place on Nov. 3. At this early stage, that preparation is largely dedicated to facilitating absentee voting. In August, the Clerk's Office mailed out more than 1,200 applications to qualified absentee voters, and will use the replies to send out absentee ballots for the General Election. In the May Special Election, more than half of the ballots cast were absentee.



If you are registered to vote in Michigan, you are eligible to obtain an absent voter ballot if you are:

- Aged 60 or older
- Unable to vote without assistance at the polls
- Expecting to be out of town on election day
- Unable to attend the polls for religious reasons
- Appointed to work as an election inspector in a precinct outside your precinct of residence

The last day to register to vote in the General Election is Oct. 5. If you are a City resident hoping to vote absentee, contact the City Clerk's Office at 228-0430.

## Medicare Open Enrollment

The Marquette Senior Center is pleased to announce that their social work staff will be offering MMAP (Medicare/Medicaid Assistance Program) assistance again this year. As MMAP counselors, they are available to assist seniors with the important and often confusing decisions pertaining to health insurance. MMAP counselors are trained in health benefits counseling, including Medicare, Medicaid and other insurance products. The social work staff is not licensed as insurance agents and does not advocate for any insurance company. The social workers can help you:

- Understand Medicare and Medicaid.
- Compare and enroll in Medicare Part D or Medicare Advantage plans.
- Review your Medicare Supplemental Insurance needs.
- Apply for Medicaid or a Medicare Savings Program.
- Determine eligibility and apply for low income subsidy assistance.
- Identify and report Medicare and Medicaid fraud, abuse and/or scams.

Anyone who joined a Medicare prescription drug plan last year will soon receive an Annual Notice of Change from the company with which they have drug coverage. Recipients are asked to read the notice CAREFULLY, as this notice will identify whether the plan is changing premiums, co-pays, deductibles and/or the prescription medications that will be covered. It's important to make sure that the medications currently being taken will still be covered by your plan in 2016. If you need help understanding the notice, please call an MMAP counselor for assistance.

Beneficiaries should take the time to answer these questions:

- **COST:** Will your premium and costs change significantly in 2016?
- **COVERAGE:** Do you need more coverage in 2016? Will the prescriptions you are taking be covered by your current plan in 2016?
- **CUSTOMER SERVICE:** Are you satisfied with your plan's service?
- **OPTIONS:** Are there better plans available for my specific needs?

This year, the annual enrollment period for Medicare prescription drug plans will be Oct. 15 – Dec. 7, 2015. During this time, people should have their current plan reviewed and also see if that is still the best plan for 2016. Everyone should have their plan reviewed at this time, as your plan may have made changes for the following year that could adversely affect your coverage. For those who have opted not to join a plan in the past, now is also the time to see if enrollment into a plan would be beneficial to you. Also for those seniors who are turning 65, the social work staff can assist you in understanding what your options are as well as when you will need to enroll for the first time.

## Downtown Marquette Farmers Market

The Marquette Downtown Development Authority is pleased to announce that the Downtown Marquette Farmers Market has been awarded Lake Superior Magazine's 2015 "Best of the Lake" award for best farmers market. Thank you to all the vendors who participate in the market and to all the shoppers who make it successful. Local support is imperative to sustaining a vibrant market, as well as shoppers visiting from out of town.

In other news, the Downtown Marquette Farmers Market is the first in the state to receive the new Michigan Department of Agriculture and Rural Development's farmers market food license, which allows food from demonstrations to be distributed for tasting. With this licensing now in place, several food demonstrations are scheduled in coming months, in addition to the market's special programming, live music and educational opportunities. Cooking demonstrations will be held most weeks through September and into October. The YMCA of Marquette will have a series of cooking demonstrations focused on the Achieve Restaurant program, brought to you in part by Michele Boehmer, registered Dietitian from U.P. Health Systems, Lynn Krahn from MSU Extension, Rachel Harris from MARESA and Monica Nelson, Registered Dietitian with the YMCA. Discover Michigan Fresh will be at the market through the end of October providing shoppers with information and to answer any questions on how to use and store the delicious food that is found at the market. What will you find in season during the months of September and October? Apples, peaches, pears, honey, beets, broccoli, brussel sprouts, cabbage, carrots, cauliflower, celery, corn, eggplant, garlic, onions, parsnips, peppers, potatoes, pumpkins, tomatoes, winter squash and much more.

In addition to highlighting the fabulous food at the market, programming will also provide area artisans a venue to demonstrate their talents. Local weavers will be at the market in October, knowledgeable garden enthusiasts will lead programming in mid-October, and pumpkin-carving on Oct. 24 and 31 will allow children their chance to be creative as well.

The farmers market has fabulous food and locally made artisan goods as well, such as wood-turned bowls, woven rugs and hand-forged knives. 



This year's Fire Prevention Week takes place Oct. 4-10. The Marquette City Fire Department will host their annual Static Display Kick-Off Parade on Saturday, Oct. 3, at 11 a.m. (rain date is Saturday, Oct. 10). The display will be located on Bluff Street, directly behind Harlow Park.

The event will showcase a variety of emergency vehicles from various departments throughout Marquette County. Kids can see vehicles up close and talk to the firefighters on hand. Sparky the fire dog will be there along with refreshments. There will also be raffles for bikes and debit/gift cards for the kids!

This year's campaign focuses on the importance of having a smoke alarm in every bedroom. According to the National Fire Protection Association, "The risk of dying in reported home structure fires is cut in half in homes with working smoke alarms." So remember the slogan: "Hear the BEEP where you SLEEP" – because working fire alarms save lives! Hope to see you there!

## Changes to Third Street Corridor

The City of Marquette continues to move forward with the implementation of the Third Street Corridor Sustainable Development Plan. The most recent improvement was the establishment of a dedicated bike lane and "sharrow" markings that provide for safer multiple use of the street by bicycles and motor vehicles.

The dedicated bike lane runs parallel with Third Street on the southbound lane and the "sharrow" markings appear in the northbound lane. The dedicated bike lane is a space dedicated for bicycles to travel with the flow of traffic, permitting them space, while a "sharrow" marking serves as a reminder for bicycles and motor vehicles that the travel lane of the street is for shared use in accordance with the Michigan Uniform Traffic Code. Both markings are supported by the City's Complete Streets policy and the desire of the community captured in the Third Street Corridor Sustainable Development Plan.

Both markings were designed and placed in accordance with the American Association of State Highway and Transportation Officials.



# Fall Yard Waste and Brush Collection— Neighborhood Zone Map



Below is the residential neighborhood zone map for the City of Marquette's fall yard waste and brush collection. As of the date of this publication, the schedule is as follows:
